OKMQA - Minutes of January 20, 2018

- 1. Meeting called to order by Vice-President, Brenda Esslinger, at 10:10 a.m.
- 2. Minutes A motion was made by Nancy Griffin to amend the Minutes from the last meeting to show the election of Colleen Billen as Treasurer. Motion seconded by Linda Eiseman. Motion Passed. The current officer team consists of Sandy Gard, President; Brenda Esslinger, Vice President; Colleen Billen, Treasurer; and Diane Cerny, Secretary.
- 3. Treasurer's Report
 - a. Colleen Billen discussed the Treasurer's Report and asked for guidance in the amounts of budget items. The budget will be voted upon in the April meeting.
 - b. Al Coster will remain on the checking account as a backup for the sake of continuity.
- 4. Committee Reports:
 - a. Activities
 - i. Brenda Esslinger reviewed the prior challenge: Negative Space Quilting. Members showed their work.

- ii. Brenda issued a new challenge: Make a collection of background fills. Load muslin onto your machine and stitch areas with fills. This piece is handy when discussing quilting choices with customers.
- iii. Brenda teased that the next activity will involve using one of the fills in different scales.

b. Membership -

- i. Currently 37 members. Discussion regarding many members who have not paid their 2018 dues. Discussion as to how to encourage prompt dues payment. Colleen Billen read dues info from our By-Laws. Our dues run from January to January. We start collecting dues in October. Dues not paid by the January meeting are considered delinquent. Annual dues of \$15 may be paid in person at a meeting, or mailed to Membership Chairman, Brenda Williams. Only dues-paying members will be listed on the public member list.
- ii. Discussion as to reducing member lists to two (2): Private, and Public.
- c. Newsletter Nancy Griffin will serve as Newsletter Chairman. Please send articles to her for the newsletter.
- d. Library Rita Torneten stated we had received a donation to the library from a member. She also stated she is checking the inventory list and checkout lists to create an updated record.

e. Programs -

- i. Brenda Esslinger led a discussion of program ideas. It was decided to have a roundtable discussion of Best Practices as the Program in the April 21, 2018, meeting. Members will share ideas and concerns in running their businesses, quilting, etc. All members present will have an opportunity to contribute ideas to the discussion. If it applies, bring a physical example of your Best Practice.
- ii. For the July 21 meeting we will have a Garage Sale. Members may purchase a table for \$10. You may share a table with a member friend for \$5 each. Sales will be by our guild members. The sale will be open to the public. The sale will be from 11 a.m. to 4 p.m.
- f. Small Groups Al Coster reported the small group at Beth's in Blanchard is going well with a good turnout. They are a social group but have projects that focus on quilting.

5. New Business –

a. Brenda Esslinger asked who uses the Yahoo group. Members discussed problems in using the group. It was stated that the person in charge of the group has not

attended in years. Discussion was held of the need for a member-only platform to be used in private group communication. It was decided to have the webmaster put a notice on the web page directing people to our public Facebook page. Brenda Esslinger will create a private Facebook page that only dues-paying members may access. The members allowed will be updated annually after the January meeting.

- b. Discussion held as to participating with a booth in the Edmond Quilt Show to be held August 3-4, 2018. Members will have the opportunity to sign up for shifts at the April and July meetings.

- 7. Show and share Several members showed their work.
- 8. Meeting adjourned at 12:30 p.m. with plans for a short break, then a video program.

We're also going to work on getting the board to meet ahead of time so that we don't clog up the general meeting with our business.

For April's meeting we are going to share our best business practices for the benefit of the new quilters in the group as well as discussing the ups and downs of quilting for the public. We are looking for everyone to participate by either giving advice or asking questions. Most of us will likely be doing both.

Because of the difficulty of using the Yahoo group we are setting up a second Facebook page that will be private. The current public page will continue to run, but to be a part of the second page you must have paid your dues for the year. I like to do mine with matching thread on one side and a thread that shows on the other side.
